TRIP WAIVER FORM

A. I understand that the tour is arranged and managed by GWD Tours, LLC., Wichita, Kansas (herein referred to as "GWD").

B. I understand that the tour begins upon boarding the charter bus on 13 March 2020 and ends upon completion of the journey back to Wichita, Kansas on 22 March 2020.

C. I agree to release, indemnify and hold harmless GWD and its affiliates (which term shall include chaperones, agents and employees of GWD as well as GWD itself) and representatives, and my school/school district, my school board and group leader (the "Released Parties") from, and agree not to sue the Released Parties for any and all claims, demands, actions, lawsuits, settlements, judgments, damages, losses, costs and expenses of any nature whatsoever (including attorneys' fees) on account of or arising out of any and all personal injury, death, bodily injury, mental anguish, emotional distress, physical, property or other damage that I may suffer from any cause whatsoever related in any way to my participation in any GWD sponsored tour. I further agree to release, indemnify and hold harmless the Released Parties from any and all acts of God, war (whether declared or undeclared), terrorist activities or threats of terrorist activities, instability in a destination, incidents of violence, public health issues or quarantine or threats of public health issues, substantial currency fluctuations, strikes, government restrictions, fire or severe weather conditions that make it impossible or commercially unreasonable in the opinion of GWD to conduct the tour, or the acts or omissions of any other agents over which the Released Parties have no direct or indirect control, including, without limitation, airlines, railways, bus companies, hotels, shipping companies, guides and sub-contracted agents or tour operators. I understand and acknowledge that GWD does not own or operate any entity that provides goods or services on my tour.

D. I understand and agree that the Released Parties shall have no liability or responsibility for me when I am absent from GWD-supervised activities or for non-GWD supervised activities, such as visits to friends/relatives or shopping.

E. I understand and agree that GWD reserves the right to refuse or cancel my registration at its sole discretion.

F. I agree to abide by GWD's regulations (see below) and the directions of my group leader and chaperones during my tour. Failure to do so may result in GWD terminating me from the tour immediately. I understand that to disobey such rules or directions is to waive the right to a refund of any part of my fee and that GWD may then send me home at my own expense.

A. Smoking is not allowed on buses, in hotels, or any other shared enclosed space.

B. All scheduled activities are obligatory. If the traveler is ill, they should notify a chaperone immediately.

C. Illegal activities (including drug possession and shoplifting) will not be tolerated and are grounds for immediate dismissal from the tour. All costs to return home are at your expense.

D. Requests to leave the group to visit family/friends must be made in writing and signed by a parent/guardian.

E. Travelers are expected to respect curfew. Members of the opposite sex are not permitted in your room after curfew. If a member of the opposite sex visits your room before curfew, the door must be left propped open.

F. Travelers are expected to stay with the group unless given permission to leave. When given permission to leave the main group, travelers must always be in groups of at least four. Travelers must always stay within the prescribed boundaries of the day's activities. For example: When we are at a museum, travelers may not leave the museum, except with the main group.

G. I understand and agree that if I become ill or incapacitated, GWD or my group leader may take any action they deem necessary for my safety and well-being, including securing medical treatment (at my own expense) and transporting me home. GWD retains the right, in its sole discretion, to contact the participant's parent(s) and/or guardian with regard to health issues or any matter whatsoever that relates to participant's tour. These rights transcend any and all privacy regulations that may apply. In the event of a medical emergency, GWD representatives may attempt to cause appropriate treatment to be administered, and the participant authorizes GWD and their representatives to do so (see next page). GWD, however, makes no warranty that either of them will be able to cause effective (or any) emergency treatment to be administered.

H. I understand and agree that GWD has the right to make changes in tour itineraries and departure times, and to modify transportation arrangements, including the use of substitute charters and chaperones.

I. I understand that I will be required to pay for any phone calls or incidental personal expenses that I incur at hotels, as well as for any damage I cause to hotel rooms, buses or other property.

J. I understand that this tour is not sponsored by any public school, public school district or other public entity, and is operated and organized by a privately owned company.

K. I understand and consent that GWD may use any likenesses taken of me and any of my comments while on an GWD tour for a digital scrapbook to be distributed to the tour's participants or future publicity.
